Eligibility and Requirements:

- For new and existing commercial, industrial, and multifamily facilities with commercial meters located within Snohomish PUD service territory.
- New construction facilities required by Washington State to install EV infrastructure in 5% of parking spaces are eligible for a \$500 rebate per port.
- Existing facilities requiring infrastructure construction are eligible for a \$1000 rebate per port.
- The EV charger must be purchased and permanently installed. Leased EV chargers are not eligible.
- The installed chargers must be Level 2 ENERGY STAR certified and listed on the **Qualified Products List (QPL)** (available via snopud.com/evbiz) in effect at the time of purchase.
- This rebate is per port (or "plug"), and the maximum number of ports is ten (10); or up to five (5) dual-port EV charging stations.
- Rebate may not exceed charger purchase price (New Construction) or total project cost (Existing Facility).
- Rebate must be submitted within 90 days of purchase.

Application Instructions:

- Purchase and install qualifying EV charger in a new or existing commercial, industrial, and multifamily facility where there is an active meter using Snohomish PUD electric services.
- Rebate may not exceed charger purchase price (New Construction) or total project cost (Existing Facility).
- Review Terms and Conditions of this application and sign the Acceptance of Terms below.
- Email this completed and signed application with the following supporting documents to **eebiz@snopud.com**.
 - Attach a clear legible copy of your itemized sales receipt that shows retailer name, address, phone number, purchase date, manufacturer, model, purchase price and proof of payment. If applicable, contractor invoice must also include contractor name, installation date and installation address.
 - Current W9 Form or for companies outside the US, current W8BEN Form.

Rebate processing will take 6 to 8 weeks.

Rebate payment will be sent per W9 or W8BEN listing.

Terms & Conditions

This rebate is available to Snohomish PUD non-residential customers with an active PUD metered account. Snohomish PUD is not responsible for lost, late, illegible or misdirected submissions. Participant acknowledges that program is subject to availability of funds, and that rebate amounts and eligibility requirements are subject to change, at any time without notice. The rebate cannot be combined with any other Snohomish County PUD Energy Efficiency rebates, rewards or incentives and cannot exceed the installed cost listed on the purchase receipt or project invoice. Participant agrees to assist, or request that the EV charger manufacturer assist, the PUD by providing charging information upon request. Participant also agrees to be added to a list of customers notified by the PUD if a demand-response program suitable for EV charger owners becomes available. Participation in a demand-response program will be optional and subject to the program's terms and conditions.
