## How to qualify

To be eligible for the PUD's manufactured home incentives:

- Home must be electrically heated and located within the PUD's electric service area
- Home must be ENERGY STAR or ENERGY STAR with NEEM+
- A copy of the Northwest Energy-Efficient Manufactured Housing Program™ (NEEM) Certificate of Compliance must be included with application and dated after the Purchase Agreement.\*
- Incentive application must be received within 180 days of the NEEM Certificate of Compliance issue date.\*

- The PUD will review rebate application to determine eligibility
