

**Free Charging Incentive FAQs** 

# Which electric vehicles are eligible for the Free Charging Promotion?

New and pre-owned plug-in, four-wheel light-duty passenger battery electric vehicles (BEV) or plug-in electric/hybrid vehicles (PHEV) purchased or leased from an auto dealership. Vehicles purchased through private sale do not qualify.

# Teslas are purchased direct through the manufacturer, not through franchised dealerships. Do they still qualify for the \$200 charging credit?

Yes, Teslas do qualify. Along with the application and a copy of the DOL registration, we will need a copy of the Tesla Motor Vehicle Purchase Agreement-Final Price Sheet.

## Do used Teslas qualify for the incentive?

Yes, pre-owned Teslas are eligible.

#### Can I get my charging credit paid to me directly?

No. The charging credit will only be applied to the PUD account. This is a non-refundable credit.

#### Why is the credit only available for electric vehicles?

PUD is supporting the adoption of electric vehicles. The incentive is intended to offset the cost of charging an electric vehicle at your home.

#### What is the \$200 EV charging credit based on?

The credit amount offsets the average annual home charging cost of an electric vehicle.

#### Can the EV charging credit be applied to a different PUD electric account?

The charging credit can only be applied to the PUD account with the same address as the vehicle registration as the credit is to offset the cost of home charging.

## What happens if I move out of the home where my vehicle is registered?

The credit can transfer to a new PUD account if you move within the PUD's territory. If you move out of PUD's service area, the credit will not be refunded to you.

## Does the credit only apply to pure electric vehicles?

The credit can be applied to both battery electric (BEV) and plug-in electric/hybrid vehicles (PHEV)

## Is there an approved list of eligible vehicles?

There is no list of eligible vehicles. Vehicle must be a new or pre-owned, plug-in, four-wheel light-duty passenger battery electric vehicle (BEV) or plug-in electric/hybrid vehicle (PHEV).

## If I purchase or lease more than one electric vehicle, can I get the charging credit for both?

Yes, each eligible electric vehicle purchased or leased qualifies for the charging credit. . Each credit will be applied to the PUD account with the same address as the registration address.

## How do I apply?

Complete the application available at **snopud.com/charging** and be sure to include the required supporting documents:

- Purchase or lease of a new or pre-owned vehicle (including pre-owned Teslas not purchased through Tesla)
  - » Copy of Department of Licensing Registration
  - » Copy Sales/Lease Contract
  - Purchase or lease of a new or pre-owned Tesla through Tesla
    - » Copy of Department of Licensing Registration
    - » Copy of Tesla Motor Vehicle Purchase Agreement–Final Price Sheet Submit your application and supporting documents to **ce@snopud.com**
