USER ACCOUNT SERVICES TERMS AND CONDITIONS

Welcome to Snohomish County PUD's MySnoPUD website. This website (the "Website"), MySnoPUD, and User Account services (the "Services") are operated by Accelerated Innovations on the MyMeter platform on behalf of Snohomish County Public Utility District ("we," "us," "our," "SnoPUD" or "MySnoPUD"). Our headquarters are located at 2320 California Street, Everett, WA, 98201, telephone: 425-783-1000. Your use of this Website and the Services is governed by the following Terms and Conditions.

Terms and Conditions

General

We provide a variety of information and services to our electric and water customers. You may use these Services solely for your own internal, residential, or business purposes and pursuant to these Terms and Conditions. If you breach and/or fail to comply with any of these Terms and Conditions, SnoPUD may terminate your account and use of these Services. We may at any time modify or discontinue any aspect or component of the Services. If you breach any of these Terms and Conditions, we can terminate your right to use the Services. All information provided and entered on this Website can and may be viewed by Snohomish County PUD (SnoPUD).

1. User Accounts

- a. These Services will offer our customers a variety of functions and services, as described more fully below in Section 2. Many of the Services will involve information about customer accounts and other personal information. We reserve the unqualified right (i) to accept or decline to accept an application to open a user account; (ii) to terminate any user account; and (iii) to discontinue the provision of any Service related to such user account.
- b. In connection with opening your user account, you will designate a user ID (email address) and password that you will use to establish your identity when you log in to use certain Services. You agree (i) to provide accurate and complete information when opening a user account; (ii) to update your information (that can be edited) as necessary so it remains accurate and complete; (iii) to create a user ID (email address) that does not include profane, vulgar or otherwise inappropriate words; and (iv) not to operate under an alias or otherwise conceal your identity. The PUD will advise if the email or user ID is noncompliant. Failure to comply can result in termination of your account or user ID
- c. The right to use the Services and functions of a user account on the Website is limited to you as the party enrolling and those authorized persons to whom you give your user ID (email address) and password. You are responsible for safeguarding your user ID (email address) and password and agree to hold Snohomish County PUD and Accelerated Innovations harmless from any claims resulting from its improper use. You agree to be responsible for all acts or omissions with respect to access to or use of a user account by you and/or any person using your user ID and password. If you believe that the security of your user ID or password has been compromised, please notify us as soon as possible by phone at 425-783-1000 (Monday through Friday, 8 a.m. to 5:30 p.m.) and take all steps necessary to immediately change your user ID and password.
- d. Information collected from you on this Website (including information about your electric and water account and personal information) is subject to our MySnoPUD Privacy Policy. You can view it by going

to our Website at snopud.com/MySnoPUD and clicking on “MySnoPUD Privacy Policy” under Important Documents.

2. Services

- a. **Bill Payment Services.** As a customer, you will be able to pay your SnoPUD water and electric bills by using the bill payment service within the website services. Payments can be made with Visa or MasterCard debit cards and credit cards (except pre-paid credit cards) and payments from bank accounts. Business customers may be limited to use only ACH payment method and have a capped dollar amount. SnoPUD reserves the right to limit or block payment options by individual customers and/or accounts pursuant to SnoPUD’s credit policy.
- b. **Other Included Services.** Residential and business customers may also use the following services: (a) View their monthly electric and water statements, (c) view their payment and bill history (up to three years of account history), (d) see their current account balance, (e) manage alert preferences including text capabilities, (f) view consumption history, and (g) export history.
- c. **Users of these services** are subject to all SnoPUD credit policies, procedures and regulations.
- d. **Brochures, Notices, Documents and Bill Messages.** Customers will receive, via email and/or links through the MySnoPUD website, related information, Notices, Documents and Bill Messages distributed by SnoPUD to its customers.
- e. **Emails and Text Messages.** Customers will receive email notices and ability to opt in for text messages for the following:
 - 1) Enrollment confirmation – Email only
 - 2) New bill
 - 3) Rejected Payment
 - 4) Forgotten password – Email only
 - 5) Autopay Enrollment – Email only
 - 6) Autopay Unenrollment – Email only
 - 7) Secondary Access invite -Email only
 - 8) Late payment/Past Due notice
 - 9) Due Date reminder
 - 10) Payment Receipt
 - 11) Payment Applied
 - 12) New Document
 - 13) Other customer communications
- f. **Paperless Billing.** By use of this website application and except as otherwise provided herein, customers can opt-in to receive email for bills, notices and information that are available through MySnoPUD. Customers must provide email addresses to continue to use MySnoPUD. Customers who want to continue to receive these items in the mail may elect to turn paperless billing off in the Manage Accounts tab of MySnoPUD. In addition, customers can opt-in for text message alerts.
- g. **Documents and Notices.** SnoPUD will send notification for final bills, final reminders, final notices, reminder and disconnect notices via first-class mail, email and text message to customers in connection with the use of the Services.

3. User Conduct

While using the Services, you may not:

- a. Retransmit, republish, distribute, reuse, resell, repost, re-engineer, or make multiple copies of the Services or any portion thereof without our prior written consent;
- b. Upload, post, publish, transmit, reproduce, or distribute through the Website any material that infringes any third party's copyright, patent, trademark, service mark, trade dress, trade secret, or other proprietary rights, or which violates any contractual, fiduciary, or nondisclosure obligations;
- c. Engage in conduct, during use of the Website, that is unlawful, threatening, harassing, abusive, fraudulent, defamatory, libelous, or invasive of the privacy rights of others;
- d. Upload, post, publish, transmit, reproduce or distribute through this Website any material that contains advertising solicitations, bulk unsolicited emails or spam, chain letters, pyramid opportunities, or offers for the sale of goods or services;
- e. Upload, post, publish, transmit, reproduce, distribute through this Website, or place any links on this Website to any material that is vulgar, obscene, profane, hateful, sexually explicit, or otherwise objectionable;

- i. Impersonate any person or entity, falsely state, or otherwise misrepresent your affiliation with any person or entity, forge headers, or otherwise manipulate identifiers in order to disguise the origin of any content that you post or otherwise transmit to us via the Website;
- j. Upload, post, publish, transmit, reproduce or distribute through this Website any material that encourages conduct that would constitute a criminal offense, give rise to civil liability, or otherwise violate any law, regulation, or government order; or
- k. Gain access to any SnoPUD account where you are not the primary account holder or where the primary account holder has not expressly authorized your access to his/her account via these Services.

4. Termination or Restricted Use

SnoPUD may, without notice and in its discretion, restrict or terminate any person's use of the Website or Services, including but not limited to user accounts, user IDs and/or passwords. Any such restriction or termination will not relieve any person of obligations incurred and accrued prior to the effective date of such termination.

The Website, Services and/or any content, information, software, functions, and applets provided on or through the Website and/or Services are made available on an "as is" and "as available" basis. SnoPUD makes no warranty regarding any information made available through or on the Website and/or Services.
