TERMS AND CONDITIONS

This rebate is available to Snohomish PUD residential electric customers with an active PUD metered electric account and cannot be mailed outside of the United States. Snohomish PUD is not responsible for lost, late, damaged, illegible, misdirected or postage-due applications. Your rights to this rebate cannot be assigned or transferred. Homeowner acknowledges that rebate program is a limited offer and subject to availability of funds, and can be adjusted or terminated at any time without prior notice. This rebate cannot be combined with any other utility rebate, unless specified in writing by PUD. Rebate cannot exceed the cost listed on the purchase receipt.

Excessive submissions constitute fraud and may result in federal prosecution under the U.S. mail fraud statutes (Title 18, USC 1341 and 1342). All submitted materials become property of Snohomish PUD and will not be returned. Resale products, products leased, rebuilt, rented, refurbished, purchased at auction, received from warranty or insurance claims, won as a prize, received as a gift, purchased with rewards points, and new parts installed in existing products do not qualify.

Snohomish County PUD (PUD) offers an Electric Vehicle Charger Rebate to customers who purchase and install an ENERGY STAR certified Level 2 connected EV charger at their residence within PUD's service territory. Homeowner agrees to be contacted about and participate in future PUD EV charger programs, and agree to provide, or authorize the EV charger manufacturer to provide, PUD access to their charging data. The data collection will be used to conduct research on EV charging patterns and their collective effect on PUD's electrical system and develop strategies to mitigate their impact. In addition, Homeowner expressly agrees that the PUD may release the Homeowner's account information, including billing and energy usage information, to an independent third-party evaluator solely for the purposes of evaluating this program, confirming energy savings, and for other quality assurance purposes. This consent takes effect on the date of installation of the electric vehicle charger or the application date, whichever is later, and remains in effect for five years. Homeowner also agrees to participate in current or future demand response programs offered by the PUD for which the PUD determines Homeowner is eligible. Participation in any demand response program is subject to the terms and conditions of that program. This consent takes effect on the date of applying for this rebate and remains in effect for five years.
