# DETERMINATION OF NONSIGNIFICANCE (DNS) (WAC 197-11-970)

### Name of Proposal:

Camano Substation

#### **Description of Proposal:**

The proposed project includes expansion and upgrading of the existing electrical substation located at 531 E North Camano Dr, Camano Island, WA. The project site consists of 2.16 acres and includes expanding the fenced yard from approximately 25,580 sq. ft. to 36,560 sq. ft. to accommodate three transmission lines. Upgrades to the stormwater system, spill containment and security fences are also included in the project. The upgrades will provide additional electrical capacity and reliable electrical service to Camano Island. Site construction is proposed to start in June 2024, with substation electrical construction occurring through 2025.

The project is located at 531 E North Camano Dr, Camano Island, Washington. Section 20, Township 32 N, Range 3E.
