NOTIFICATION OF SEPA DETERMINATION

November 7, 2023

This letter is to inform you that Public Utility District No. 1 of Snohomish County has evaluated the proposal described below under the State Environmental Policy Act (SEPA) and made a determination concerning the potential impacts. The evaluation for this proposal included a comprehensive review of current and past environmental documents related to the Nonproject Action proposal.

Name of Proposal: Draft Snohomish PUD 2023 Integrated Resource Plan (IRP) Update

Description of Proposal: The draft Snohomish PUD 2023 Integrated Resource Plan (IRP) Update is a non-project action that proposes a long-term resource strategy to provide reliable electric service to customers at the lowest, reasonable cost, under a variety of futures the PUD could face over the period of 2024 through 2045. To achieve this objective, a range of alternatives is considered. This requires a plan that is flexible for the PUD, and that can adapt to changing circumstances without adverse financial impacts or other risks. The plan also incorporates a near term action plan that implements the long-term resource strategy. The proposed long-term resource strategy and action plan are considered for adoption by the Board of Commissioners of the Public Utility District No. 1 of Snohomish County. Any Washington state utility with more than 25,000 customers must conduct a comprehensive integrated resource planning process every four years and provide an update to its plan every two years, per Chapter 19.280.030, Revised Code of Washington. To the extent a particular project or generating resource is contemplated as it relates to one of these programmatic activities, the project itself would undergo a more comprehensive analysis, of a type that is appropriate to the project, including a project-specific environmental review. The draft 2023 IRP Update was initially presented to the PUD's Board of Commissioners for consideration on October 30, 2023.

Proposal Location: The draft Snohomish PUD 2023 Integrated Resource Plan (IRP) Update is a non-project proposal that does not include specific locations or projects.
